May 2016

This report provides an overview of the development and use of SQA Digital Question Papers (DQPs) in the 2015 examination diet.

CALL has collated and published data on DQPs since they were first introduced in 2008 and the last full report covered the 2013 diet.

To maintain continuity and provide longitudinal data, we have produced short reports for subsequent years beginning from 2014.

The data used in this report was provided by the SQA Statistics team.

This work was funded primarily by the Scottish Qualifications Authority.

2015 Assessment Arrangements

In 2015 there were 43,997 requests for Assessment Arrangements on behalf of 14,489 candidates, representing 11.1% of the total number of entries and 6.67% of the total number of candidates. This represents a small increase in the number of requests and candidates using Assessment Arrangements (Table 1).

The number of requests for Assessment Arrangements fell by almost 30% following the phasing out of Standard Grade examinations in 2014. This was partly due because there were fewer examinations entered overall (-9%), and also because Assessment Arrangements are more commonly requested at lower levels of qualification (Table 3) and were more often used in Standard Grade Foundation and General examinations, which were no longer offered.

While the percentage of National 5 entries where assessment arrangements were requested has increased from 5.7% to 7.8%, it is striking that arrangements for National 5 are requested half as often as they are for Intermediate 2, which are at the same SCQF level. There are clearly other factors

that are influencing the use of Assessment Arrangements in the new qualifications, other than the level of the assessment.

Types of Assessment Arrangements

Most requests for permission to use AA specify more than one type of support and so the 43,997 requests in 2015 comprise 97,328 specific types of support (Table 4).




Figure 1: Number of requests for most popular methods of support, 2008-2014

Figure 1 shows the number of requests for the most popular methods of support for the years 2008 to 2015 (excluding Extra Time, Separate Accommodation and Rest Period on the grounds that these are changes to the conditions rather than methods of support). Requests for ICT (including Digital Question Papers) increased by 10% from 2014 to 2015.

The number of requests for readers and scribes continued to fall in 2015: reader requests dropped to 7,819 from 9,399; while requests for scribes fell to 5,600 from 7,105. This follows the reduction of over 50% from 2013 to 2014 (Table 4; Figure 1).

Analysis by centre type

There were AA requests from a total of 428 centres. The majority of these requests came from Education Authority Secondary Schools (83.4%).

Analysis by primary difficulty

When a centre requests an Assessment Arrangement, the primary factor giving rise to the request for additional support is recorded. Table 6 gives the number of requests analysed by the type of the difficulty: more than 50% of candidates request Assessment Arrangements as a result of dyslexia or another specific learning difficulty.


The number of requests for DQPs increased slightly by 3.2% from 2014 to 2015, and the number of candidates by 7.5%. Tthe number of centres requesting DQPs also increased (Table 7): 44% of Scottish state and independent schools requested Digital Question Papers in 2015.



As noted earlier, the phasing out of Standard Grade examinations in 2014 meant that fewer examinations were entered, and as a result the number of requests for all types of assessment arrangements, including DQP, fell. The use of DQPs as increased as a percentage of the total number of requests (Figure 2and Figure 3).

DQP uptake: local authorities / sector

Table 8 records the number of requests from each local authority or sector. The range in uptake is striking and it is clear that access to this type of support in examinations is very uneven across Scotland. (The 'half' requests are because the data from SQA does not give the number of requests where the school has requested less than 5, so for these schools it could be between 1 and 5. We therefore use the median of 2.5.)

Engagement and CPD

Table 9 lists conference and training events between 1 April 2014 to 31 March 2015 where CALL staff delivered CPD or presented on digital question papers or use of ICT in assessments and examinations. In-service training is primarily funded by schools and local authorities while presentations and conferences are supported through CALL core funding from the Scottish Government. This direct engagement with staff and parents helps raise awareness and builds capacity in schools and centres, and will have led at least in part to the increase in use of DQP across Scotland.
